

USAID Public-Private Alliances for FY 2002

Excluding Global Health, USAID funded 68 alliances, with \$111.2 million of USAID funds leveraging approximately \$379.7 million in outside partner contributions.

Global Health has 7 alliances with USAID funding totaling \$225 million leveraging approximately \$1.2 billion in outside partner contributions.
